**Explanation of Responses:**

- On November 6, 2021, the Reporting Person's performance-based restricted stock units ("PSUs") vested at target, resulting in the Reporting Person receiving 140,017 shares of common stock of the Issuer prior to withholding for taxes.
- These PSUs, awarded as part of the Issuer's 2019-2021 Long-Term Incentive Plan, represented a contingent right to receive shares of the Issuer's common stock upon the Issuer's attainment of goals for compound annual total shareholder return over the three-year period ended November 6, 2021. The PSUs vested at 100% of target based on the Issuer's compound annual total shareholder return exceeding 15% over the performance period. The PSUs were also subject to a time vesting requirement which was satisfied on November 6, 2021.
- The Issuer withheld 68,567 shares of common stock to satisfy the tax withholding obligations in connection with the vesting of 140,017 PSUs, pursuant to the terms of the applicable award agreements.
